On June 10,2021,the 29th meeting of the Standing Committee of the 13th National People's Congress passed the Hainan Free Trade Port Law of the People's Republic of China,which determined to establish and improve the Hainan Free Trade Port customs supervision special zone systemwith closed-off customs operations on the entire island.

Will Hainan build customs supervision areas for trade liberalisation and facilitation?

Hainan will build special customs supervision areas for trade liberalisation and facilitationwhen independent customs operations are launched and the "free flow through the first line and control at the second line" trade policy is implemented.

Is Hainan a free port?

Wang Yang publishes an official definition of a free port in the People's Daily. Will Hainan become a free trade zone?
