On June 10,2021,the 29th meeting of the Standing Committee of the 13th National People's Congress passed the Hainan Free Trade Port Law of the People's Republic of China,which determined to establish and improve the Hainan Free Trade Port customs supervision special zone systemwith closed-off customs operations on the entire island.

Does Hainan free trade port have a corporate income tax policy?

The "Notice on Preferential Corporate Income Tax Policies for Hainan Free Trade Port" proposed that enterprises in encouraged industries registered and operated in Hainan Free Trade Port shall be subject to a reduced corporate income tax rate of 15%.
